2. **Please choose which statement reflects your position:**

*I support the FOLF stand to restore the traditional off-leash recreation policies at LFSB. I commit to working with the city, county and state to help achieve this goal.*

Comments:

*It is important to communicate to city, county and state officials that dog owners want to act within the law, but also feel it is important that their dogs enjoy exercise and socialization off leash.*

*Given the direct correlation between the declining economy and the rise of public safety concerns, there is a pressing need for innovative, collaborative and integrated solutions, that deliver to our local government the tools they need to ensure the safety of their citizens. I feel that through continued conversation with the City and by making FOLF part of the solution to the public safety concern we can move toward the restoration of off-leash recreation in Lighthouse Field.*

3. **Please specify any of your specific experiences that would make you most qualified candidate to help support and achieve the goals of FOLF (e.g., city, county and state government, parks and land use issues, community action, government zoning, legal, budget planning, etc.):**

Comments:

*I am running for City Council to ensure that Santa Cruz is a safe and vibrant place to live and visit, a great place to do business, and a model of environmental stewardship. Part of this vision for our community includes all of our very passionate and committed dog owners, many of whom are members of FOLF.*

*On the Parks and Recreation Commission I have been an advocate for off-leash areas in our parks and have helped find innovative solutions for creating additional areas even with current budgetary constraints. My husband and I have owned a small animal hospital in this community for over 10 years. I understand the incredible opportunities as well as the serious challenges of meeting a weekly payroll while providing services to our community's citizens. It is vital that Santa Cruz maintains an economic base that supports the local businesses which provide our citizens with good jobs and benefits.*

*From organizing volunteers and raising funds to save the Beach Flats Community Center, to building a new track and field for Santa Cruz High School students, to raising money and hope for Children's Hospice, my commitment to Santa Cruz is evident by my passion for helping my community. Santa Cruz is abundant with volunteers, friends, families, businesses, leaders and organizations that come together everyday to create positive change and make a difference in other's lives. I serve because making Santa Cruz a thriving community is important to all of us. We must all work together to create sustainable long-term plans that will move Santa Cruz forward by bringing its people together to serve the common good.*

*I will bring my results-oriented experience and collaborative energy to city government. Santa Cruz deserves a bright future and I will work tirelessly until we get there.*

Comments:

*As a dog owner, and co-owner of Westside Animal hospital, I believe that a dog's emotional health is connected to their ability to interact with their environment. Dogs who are accustomed to playing with animals and people other than their owners are more likely to be well-socialized and react well toward strangers. Well-exercised dogs are better neighbors who are less likely to create a nuisance, bark excessively and destroy property. Their presence in Lighthouse Field, along with their owners, also helps to deter crime and make our neighborhoods a safer place.*

5. **Will you take a leadership role on the City Council to move toward a City purchase and/or operating agreement for Lighthouse Field and Its Beach?**

Please explain any specific plans or commitments:

*Moving toward a city purchase and/or operating agreement for Lighthouse Field and Its Beach may need to be approached as a long-term goal. Santa Cruz is facing an unprecedented budget deficit. I do not believe it will be financially possible, in the short-term, for the city to acquire additional land while we have such significant safety issues to address, continuing furloughs, and are cutting jobs and services of our residents.*

*However, I do believe that by becoming an integral a part of the multifaceted approach to public safety, FOLF will be able to move toward a purchase or operating agreement when the next growth cycle comes around. This approach allows FOLF to set its own course for the future.*

*If elected for City Council I would take a leadership role to understand budgetary constraints and work with FOLF to help position the organization to participate with innovative solutions to the City's current challenges.*

6. **Will you take a leadership role on the City Council to move toward a City purchase and/or operating agreement for Lighthouse Field and Its Beach if the State is willing to negotiate providing any required EIR or negative declaration, legal defense, long-term financing, and/or participation in maintenance expenses?**

Please explain any specific plans or commitments:

*If the State were willing to negotiate with us, I would take a leadership role on the City Council to move toward an agreement on Lighthouse Field and Its Beach. It is my belief that community partnerships offer the best way to move projects like this forward. To succeed, this effort must foster a working partnership with the City and the community. Creating a consensus will ultimately speed up action and attract more partners, funders, and the help of countless individuals who want to be part of the solution.*

*I feel that one of my primary strengths is the ability to listen without prejudice and then to build consensus through a thoughtful approach to all sides of the issue.*

Please explain any other ideas, specific plans, or commitments:

*Other communities have worked successfully with their State Park's Agency to agree on leash exemptions within State Parks and through perseverance we could do the same.*

*Very recently (7/2010) in Denver and Littleton (significantly larger metropolitan cities) the Colorado State Park staff vote unanimously to create off-leash recreation for dogs. That measure was successfully passed after studies were done on the parks in question and it was determined to preserve "the dog off-leash area as an irreplaceable recreational amenity."*

*These Colorado communities did make concessions, including a usage fee, a pledge to both educate park visitors and to increase volunteer involvement to restore habitats and clean the parks. However, I feel that the Colorado State Park unanimous decision shows that there can be avenues explored or uncovered in Santa Cruz and that we can work together to modify specific park policy within our community.*

*Not enough.*

Comments:

*There have been efforts to increase the space for off-leash recreation, even given the current economic challenge. However, I do believe that this is an area that we can work.*

Comments:

*My dog, Zap, and I are beneficiaries of FOLF's goal of access for off-leash recreation for dogs and owners/guardians. Everyone has benefited from FOLF's activities to maintain a safe and clean environment at Lighthouse field and It's Beach. I have participated in 2 clean-ups and believe that the fact that FOLF has continued to care for LFSB, despite being denied shared use, speaks volumes. Years ago I supported the effort to save Lighthouse Field from the Hilton Hotel plan and, more recently I supported the City's plan to purchase Lighthouse Field when former Assembly member John Laird attempted to negotiate an extremely favorable and affordable purchase agreement that would have cost the City very little over 30 years.*

Comments:

*I have been an engaged and involved community activist in Santa Cruz on a number of issues over the past 40 years and appreciate and understand the importance and need for citizen involvement. In addition to broad and deep connections within our community, I also have developed a good relationship with Assembly member Bill Monning and with future Assembly member Luis Alejo. I have worked with State Senator Joe Simitian in support of the Rail-Trail and legislation to keep radioactive smoke detectors out of the landfill. As a member of the Transportation and Public Works Commission and former Water Commission member I have insight into citizen bodies. My wife, Jane Weed-Pomerantz, served on the City Council some 25 years ago where I first learned about our City's governance. *The FOLF community has been extremely patient and understanding of the budget constraints the city has been facing. It has kept us from moving forward on many of the important issues facing the hardest hit department, which is Parks and Rec. It will take all of the agencies working together with the community to create a new stewardship model for off leash recreation. The stewardship that FOLF have dedicated over the years is clearly evident, and the last few years clearly showed what happens in the field when recreational activities change. Criminal activity and illegal camping begin to claim the space left void, and it does take the entire community to help reclaim the space. Thank you for your leadership and connecting with Take Back Santa Cruz for the big clean up you recently accomplished.*

*[Note: Because Lynn Robinson answered Question 9 to give relatively low priority to shared open off-leash space -- as had been the case in LFSB prior to Nov. 2007 -- we followed up with her to clarify her position on restoration of off-leash at LFSB. Although she would generally prefer to create more dedicated areas for new off-leash areas (i.e. separation of dog and non-dog areas), with respect to LFSB she supports "... the same off leash limited hours of before 10am and after 4pm." I.e. the traditional pre-2007 sharing model that we support.]*

Comments:

*I have worked with FOLF directly in my role on the City Council. I have been in the negotiations that have taken place over the last four years. My relationship with all the agencies involved is a very strong working relationship and I have a working knowledge of the issues. I recognize this is moving slowly mostly due to our budget constraints. Parks and Rec has been severely cut back in the last few years in order to help the City balance the budget, and any rebound is going to be slow. I don't get discouraged though, and that is one of the reasons I am running for City Council again. You need someone with the experience and deep knowledge of the issues. I already have the working relationships required to help move forward on the issues FOLF is focused on.*

*I can tell you from my current experience on the council, the budget cuts have been extremely difficult for everyone. It is important for me to be very upfront with FOLF as I have been at the table for all the work we have been able to accomplish on the proposed acquisition. The most extreme cycle of the economic downturn happened at the same time we were trying to work out the details for the Lighthouse Field and beach. The dire state of the Parks and Rec cut backs have kept the EIR from being completed. The department prioritized the heroin issues in Pogonip with the resources they currently have, so I am being realistic in my answers to you. I will keep it moving forward, and I am keenly aware it is not happening at the pace FOLF had hoped.*

*The more realistic approach would be to look at an operating agreement that can be worked out with the City and the State. With the drastic cuts that have happened in the last few years to the Parks department, even an operating agreement would be a challenge, given the resources needed to manage the park. Again, I want to thank you for understanding we need to look at realistic options on how we can get the agencies and community together and move forward on this issue. Purchasing can still be an option, but in these economic times, I think being open to an operating agreement makes sense.*

*I have a very good working relationship with staff at the State Parks. I would be happy to work with the State to move these ideas forward. They know the issues that face us in Lighthouse Field. I was out of town for the recent cleanup that FOLF and Take Back Santa Cruz organized, but I have stepped up and worked with both groups doing trash cleanups of public spaces that have criminal activity taking place. The lack of resources for the State Parks has been an issue for them being able to keep the field free of camping and illegal activity. Groups like FOLF and TBSC make a positive difference in public spaces we all want improved, especially around public safety concerns.*

8. **For the off-leash recreation needs of Santa Cruz citizens, which statement best represents your position? The City of Santa Cruz provides space for off-leash recreation that is:**

*Not enough.*

Comments:

*Santa Cruz has a very active and engaged population of dog owners, as diverse as the dogs themselves. If we had more resources in the form of usable spaces and dedicated money, I would like to be creating specific dog parks. I would have a park space that was intended for large dog owners to let their dogs run without the concern for small dogs, children and seniors. Another location would be for smaller breeds that sometimes get over run by the large breeds. Elsewhere there would still be an off leash dog park for all dogs. The City of Danville created two different parks to fit the needs of large breeds and small breeds. We don't have that luxury with our current budget, and we have been creative under our current constraints to provide off leash park spaces, but there is an unmet need.*

I feel we do need to acknowledge that many parents with children as well as seniors are more vulnerable to being unexpectedly surprised by dogs that are in serious exercise mode. Creating more spaces that remove that conflict increases full enjoyment of those designated spaces.*

**10. How do you believe Santa Cruz would benefit from becoming a more dog-friendly city? How would you work toward making Santa Cruz more dog-friendly?**

*We would benefit by the network of dog friendly communities spreading the word about places and spaces that people can take their dogs in Santa Cruz. We keep growing that list all the time. Many private businesses are finding ways to be more dog friendly and it is helping us at the city level as we go in the direction of allowing more access to dog owners in the public spaces.*

*I currently work with many of the businesses that would be affected by the change in policy regarding new locations for leashed dogs in commercial spaces. I know that we will be able to accomplish this goal together with leadership from responsible dog owners, local business owners interested in creating that change, and several of us on the Council. Together we can address the concerns of having dogs in commercial areas, being realistic about the outcomes, and making a policy that brings responsible dog owners new dog-friendly opportunities in the City of Santa Cruz. I think the City of Berkeley, with their 4th Avenue business district and the City of Walnut Creek, as well as Los Gatos are good examples of what our new dog friendly atmosphere could be like.*
